Public support fraction at the end of FY7 was 20.6%, and the following text documents how this organization meets the facts and circumstances test.

This organization maintains a website to inform the public of our activities and to solicit funds from the public. We are currently working with other organizations (e.g., Kiva, Global Giving) to include a "donate online" option for public supporters, and in FY7 we were able to increase our public support fraction from 14.3% to 20.6%.

Members of our Board of Directors present information about our organization and work at a number of public forums throughout the year, at universities (e.g., MIT, Eckerd College, University of Liege), conferences (e.g., EmTech, Solar Paces), and outreach events (e.g., Innoventures)

This organization actively solicits funds from governmental units, including the National Science Foundation (NSF) and the United States Agency for International Development (US AID). Applications for funding are currently pending with USAID and the US EPA.

To date, sources of support have been through individual donations, competitive grants and prizes, and industrial donations.

The governing body focuses on two important opportunities for this organization: technology transfer and education (within the USA and outside of these borders) and development of renewable energy technologies appropriate for use in impoverished rural areas. Both goals are in line with internationally supported goals to (1) provide quality education globally, and (2) support improved stewardship of the Earth system by using renewable energy sources. Our technology test facility has been installed at Eckerd College (St. Petersburg, FL) to provide a tool for both undergraduate and community education efforts; we have simultaneously been developing matching curricula which cover related engineering, energy, and social justice topics. This facility is open to the public for visitation during regular campus hours.
