Public support fraction at the end of FY6 is 26.1%, and the following text documents how this organization meets the facts and circumstances test. This organization maintains a website to inform the public of our activities and to solicit funds from the public. We are working with other organizations (e.g., Kiva, Global Giving) to include a "donate online" option for public supporters, which increased our public support from 21% to 26.1% over the past year. Members of our Board of Directors present information about our organization and work at public forums throughout the year, including at universities (e.g., MIT, Eckerd College, University of Liege, National University of Lesotho), conferences (e.g., EmTech, Solar Paces), and outreach events (e.g., InnoVentures).

This organization actively solicits funds from governmental units, including the National Science Foundation (NSF) and the United States Agency for International Development (US AID), and the United Nations Development Programme (UNDP). We also solicit funds from African governmental units, such as the Government of Lesotho, and are working to prepare an application to the African Development Bank.

To date, significant funds have been received from the World Bank and individual donations, as well as receipt of funds from competitive grants and prizes as well as industrial donations.

The governing body focuses on two important opportunities for this organization: technology transfer and education within Lesotho, and development of renewable energy technologies appropriate for use in impoverished rural areas. Both goals are in line with internationally supported goals to (1) provide quality education globally, and (2) support improved stewardship of the Earth system by using renewable energy sources. To date we have worked with a number of community partners within Lesotho including a vocational school, the National University, the Ministry of Health, the Ministry of Education, the Ministry of Science and Technology (Appropriate Technology Services), and NGOs working in the health sector in Lesotho. We have supported incorporation of a partner NGO in Lesotho, currently implementing a grant from the UNDP Small Grants Programme to work with our organization in scaling up education and outreach efforts focusing on solar energy technologies. We also have a solar test facility installed at a health facility in Lesotho to provide energy to the facility and document benefits gained through the electrification process; this is in partnership with the Lesotho Ministry of Health.
